SYNOPSIS OF INCIDENT:

On 7/28/16 at approximately 1100hrs, Bowie Units responded to a theft in progress in the 15500 block of Emerald Way - Bowie, MD. While in route, Units were advised by Prince George's County Dispatch that one of the suspects involved threatened an employee with pepper spray. Upon arrival, Bowie Officers spoke with employees at the location who stated that 3 female suspects walked in and began removing multiple items off of the shelves. As they were exiting the store, one of the suspects turned in the direction of an employee, pointed a can of pepper spray at the employee, and told her to back up. The suspects then left in a waiting red vehicle in an unknown direction of travel. No further physical descriptors of the suspects are available at this time. The Bowie Officers contacted Prince George's County Police (CID Robbery Unit), who will be assuming control of this investigation.

There were no reported injuries.
