**INCIDENT: First Degree Assault Arrest**

**LOCATION: 15700 Block of Piller Lane - Bowie, MD, 20716 LOCATION TYPE: Townhome**

**SYNOPSIS OF INCIDENT: On January 30, 2015 at 2159 hours, Bowie Police were dispatched to a cutting at 15700 Block of Piller Lane. Once on scene Officers observed the victim lying on the floor of the living room holding his neck where he was suffering from a knife wound. The Prince George's County Fire Department then arrived on scene at which point they stabilized the victim and transported him to Prince George's County Hospital for treatment. An investigation of the incident revealed that the victim and the arrested (Devon Holt) had become involved in a verbal dispute while at their friend's home. The arrested then produced a silver folding pocket knife and cut the victim in the neck at which point she fled the scene in a gray Mercedes station wagon. Detective Wuthrich #051 with the Bowie Police Department's Criminal Investigation Division responded to the scene to continue the investigation and PFC Booth #050 processed the scene for evidence. As a result of his investigation, Det. Wuthrich was able to obtain criminal charges against the suspect including Attempted 1<sup>st</sup> Degree Murder, Attempted 2<sup>nd</sup> Degree Murder, Assault 1<sup>st</sup> Degree, Assault 2<sup>nd</sup> Degree, Dangerous Weapon-Intent to Injure and Dangerous Weapon-Concealed. The suspect was apprehended at her residence in Capitol Heights, MD with the assistance of the Prince George's County Police Department. Nothing further.**
