### SYNOPSIS OF INCIDENT:

On 5/26/15 at approximately 2204hrs, Bowie Units responded to 6001 High Bridge Rd. for the report of a robbery in progress at the CVS Pharmacy. Upon arrival of Bowie Units, the Arrested, Antonio Adams, was detained after being identified by store employees for attempting to steal money from the register. Employees stated that the Arrested walked up to register #2 of the pharmacy and proceeded to reach over and grab multiple denominations of US currency out of the cash drawer. The Arrested was then delayed by store employees from leaving at which time he became angry and violent. Arrested began assaulting and chasing a male employee until Bowie Units arrived. Bowie Police CID was also notified and responded out to the scene. After interviewing store employees, the Arrested was placed into custody and transported to Bowie Police Department for further questioning. Prince Georges County Fire Medic 816 was also dispatched to the scene for possible injuries to the Arrested or store employees, all declined medical treatment. There were no other injuries reported.

Bowie Detectives also charged him with a previous theft and strong arm robbery.
