**INCIDENT:** Recovered Stolen Vehicle (Arrest)

**SYNOPSIS OF INCIDENT:** On June 3<sup>rd</sup>, 2015 at 1152 hours while on routine patrol in the area of 12700 Brunswick Lane, Bowie Officers observed a white Ford Transit Connect van bearing Georgia registration plate VAM863 parked on the street in front of the address. A stolen check on the registration revealed that the vehicle had been reported stolen through Prince George's County on 05/25/2015. Bowie officers elected to observe the vehicle to see if it would become occupied. A short time later, four individuals entered the vehicle and attempted to leave the area. Bowie Officers stopped the vehicle and identified the occupants. Two of the occupants were identified as Ashley Rae Fuller (A1), who was the driver of the vehicle, and David Sherrod Pierce (A2). A warrant check was conducted for all four occupants revealing that Mr. Pierce had an open warrant for First Degree Assault which arose from an earlier incident that occurred in the City. The remaining three occupants had no open warrants. At this time Ms. Fuller and Mr. Pierce were placed under arrest. Ms. Fuller was transported to the Bowie Police station where she was interviewed by Detective Wuthrich and later transported to the Department of Corrections in Upper Marlboro for processing. Mr. Pierce was transported directly to the Department of Corrections in Upper Marlboro for service of his open warrant. The remaining occupants of the vehicle were released from the scene of the incident. The vehicle was released to the owner's father from the scene. Nothing further.
