**SYNOPSIS OF INCIDENT:**

On June 8, 2015 at approximately 1728hrs, Bowie Patrol Units responded to the Bowie Health Center, located at 15001 Health Center Drive, for the report of a citizen armed robbery. Upon arrival, PFC Simms #031 spoke with the victim who stated that while walking on a path in the area of the 15900 block of Excalibur Road, he was approached from behind by 4 to 5 unknown males wearing black masks. He was then struck from behind by an unknown object. An unknown suspect displayed a kitchen knife as another suspect took money from his pants pocket. The suspects then began to kick and punch the victim in his arms and chest. The suspects then fled in an unknown direction in an unknown black vehicle. The victim then walked to Bowie Health Center and hospital staff reported the incident 2 hours later.
