SYNOPSIS OF INCIDENT:

On July 1st, 2015 at approximately 2100 hours, Bowie Police Officers responded to the location of 15500 Excelsior Drive (Chipotle Restaurant) for a report of a fight in progress. Upon arrival, Officers observed a large crowd at the front entrance of the restaurant and two subjects actively engaged in a physical altercation. Officers observed that one of the subjects was bleeding and was suffering from an apparent stabbing. Officers on scene recovered the knife used in the assault and secured the location. Prince George's County Fireboard was requested and responded to the location of the incident. The subject suffering from the stabbing wound was transported to Anne Arundel County Medical Center to be treated for his injuries. Bowie Police Officers secured witness statements and concluded that two subjects became engaged in a verbal dispute that escalated into a physical altercation. The physical altercation was reportedly started by the subject who suffered the stab wound. According to witnesses, the subject reacted in self-defense and pulled a knife on the other subject after being physically assaulted and knocked to the ground. Bowie Police Criminal Investigation Division responded and took over the investigation; both subjects were then arrested and transported to Upper Marlboro Department of Corrections.
