SYNOPSIS OF INCIDENT:

On 7/14/15 at approximately 1606hrs, Bowie Units responded to 15642 Emerald Way (Verizon Wireless) for the report of a robbery in progress. Upon arrival Officers spoke with the victim who advised that (2) black males suspects entered the store and proceeded to the cell case display located at the front entrance of the store. The suspects began to take cell phone cases and place them inside of their pants. When confronted by the victim about their activity, they became hostile. The victim attempted to lock the doors of the business. At this time, one of the suspects displayed a knife towards the victim and told him “do not lock the door”. The suspects then ran out the store and fled in an unknown direction of travel with items from the store.

Bowie Police C.I.D responded to this incident.
