SYNOPSIS OF INCIDENT: On 07/25/2015 at approximately 1630 hours, Bowie Police responded to the area of the Bowie Town Center for an armed robbery. During the interview the victims advised as they were walking home on Elsmere Ct., they were approached by the arrested and asked if they had any money to which both replied “no”. The arrested proceeded to produce a black handgun and pointed it at the victims. The arrested proceeded to take \$40 from one of the victims and fled.

During the course of the investigation, Det. Wuthrich was able to obtain surveillance footage of the suspect walking through the food court at the Bowie Town Center shortly after the robbery; both victims were able to identify him as the suspect that robbed them.

On 08/25/15 while canvassing the area of the Bowie Town Center, Det. Wuthrich observed a subject that matched the description of the suspect on the video. Det. Wuthrich proceeded to make contact with subject, as he started to talk to the subject he proceeded to take off running. After a short foot pursuit, Det. Wuthrich was able to apprehend the subject. He was later identified as the arrested Yates, Donovan. During the interrogation Yates confessed to his involvement in the armed robbery.
