**SYNOPSIS OF INCIDENT:**

On February 19, 2016 at 2000hrs, Bowie Officers were dispatched to 4511 Mitchellville Road (Michaels Arts & Crafts Store) in reference to a possible DUI driver attempting to park a car. Officers observed the suspect in a black Acura sedan sitting in the driver’s seat acting in an erratic manner. Further investigation revealed that the driver was observed by witnesses driving in the parking lot, striking multiple curbs and attempting to drive onto the sidewalk adjacent to the above-listed store. Officer Simms placed the suspect under arrest. Upon inventorying the suspect’s vehicle for impound, Bowie Officers discovered 9 pounds of alleged marijuana in a blue draw string bag located in the vehicle’s trunk. The above-listed items were recovered and the suspect was transported to DOC for processing.
