**SYNOPSIS OF INCIDENT:**

On January 4, 2017 at approximately 2358 hours, PFC Stevens attempted to conduct a traffic stop in the 15200 block Major Lansdale Blvd. At this time, the vehicle drove off and crashed into a parked truck in the parking lot. The occupants bailed out of the vehicle and fled on foot into the wood line behind the Hampton Inn. A check of the tag showed that the vehicle was reported stolen from Adelphi, MD. A perimeter was set up and additional support units were called in to assist. All of the occupants were located, arrested and transported to the Bowie Police Station for processing. The adult was then taken to Upper Marlboro Department of Corrections for processing. A search of the vehicle found numerous GPS units in the trunk. Detectives will continue the investigations to determine the owners of these units.
