



INCIDENT: Citizen Armed Robbery

LOCATION: Nottingham Drive @ Noblewood Lane

SYNOPSIS OF INCIDENT: On May 9, 2014 at 2351 hours, Bowie Officers responded to the 15400 block of Neman Court for a report of an armed subject. Once on scene, Officers were advised by Victims 2-5, that at approximately 2330 hours they, along with Victim 1, were walking home in the area of Nottingham Drive and Noblewood Lane when they were confronted by the two suspects. The victims advised that the suspects stated "I swear if you run I'll shoot," at which time all the victims began running and fled the area. Victims 2-5 made their way to the 15400 block of Neman Court where they called police. Victim 1 did not return with them. An extensive area canvass was conducted at which point Victim 1 was located at the Bowie Town Center and transported back to the location of incident. At this point Victim 1 stated that when he and the other victims ran he was caught by both suspects in the area of Spring Lake Park. The suspects then demanded his property and Victim 1's cellular phone was taken. At this time the suspects fled in an unknown direction. Detective Welsh of the Bowie Criminal Investigation Division responded to the scene. A neighborhood canvass of the location of incident was conducted with negative results. The investigation is continuing.
