### SYNOPSIS OF INCIDENT:

On 11/30/14 at approximately 1640 hrs, Bowie Units responded to the 3700 blk of Enders Lane for the report of gunshots. Upon arrival Bowie Officers found a male (V-1) suffering from a gunshot wound to the lower left leg. The victim was transported to Prince Georges County Hospital for treatment.

At 2018 hrs, Bowie Officers then responded to the 4100 blk of Nottaway Ln. for a report of a victim suffering from a gunshot. Upon arrival, Bowie Officer spoke with a male (V-2) who was suffering from a gunshot wound to his lower right leg. V-2 stated that he was at the same location as V-1 when he was shot. V-2 refused any medical treatment.

V-1 initially lied about his identity. His true identity was confirmed and it was discovered that he had four open warrants for violation of probation and armed robbery.

Bowie Police C.I.D was notified along with Prince Georges County K-9 (T-110) and Prince Georges County Evidence Unit.

There were no other injuries reported.

Bowie C.I.D. will be conducting follow up investigation.
